

# The HSBC British Airways Discount Offer Terms and Conditions

1. These Terms and Conditions apply to you so far as the law and regulation permits so please read them carefully.
2. HSBC Bank Middle East Limited - UAE is the “**Promoter**” of this offer.

## The Offer

3. The offer is up to 15% discount off British Airways fares (excluding applicable taxes, charges and fees) for HSBC Premier, Advance, Cashback, Zero, Platinum Select, Platinum, and Gold Credit Cardholders within the UAE on the following selected fares:
